Notice is given in accordance with Chapter 551, Government Code and Texas Water Code Section 36.404 that the Pecan Valley GCD Board of Directors will hold a public meeting on June 17, 2025 at 9:15 a.m. at the District Office, located at 1009 N. Esplanade St., Cuero, TX. The purpose of the meeting is to conduct regular District business and hear public comment and consider possible issuance on the following operating permit applications. All operating permit applications submitted are the beneficial use for Mining Oil and Gas.

Operating Permit Application from Devon Energy on property owned by Morris and Billie Hanke. The application requests an annual production of 50 Acre-Feet of water. This property is located on US Hwy 87 N. near Westhoff and involves 106.77 acres.

Operating Permit Application from Devon Energy on property owned by Ronald and Harlen Aschen. The application is requests an annual production of 50 Acre-Feet of water. This property is located on Cheapside Rd. near Westhoff and involves 113.85 acres.
