- a. Public Hearing on the Spacing Variance from Charles Sutton III: Hearing is to receive public comments on the Spacing Variance from Charles Sutton III. This property is located at 1191 Lakeside Drive, Cuero, Texas. No public comment or objection stated.
- Discussion and consideration of spacing variance request from Charles Sutton III: A motion to approve the spacing variance request as presented was made by Tim Pennell, seconded by Marvin Sager, which carried unanimously.

The Operating Permit Amendment Application is requesting an additional 14 AF of water per year for a total of 40 AF of water per year and a combined total of 80 AF of water per year from two water wells. This property is located on FM 766 near Cuero, Texas and involves 402 acres. No public comment or objection stated.
- b. Discussion and consideration of operating permit application from BHP Billiton on Blake Muir's property: A motion to approve the Operating Permit Amendment Application in the amount of an additional 14 AF of water per year for a total of 40 AF of water per year and a combined total of 80 AF of water per year from two water wells was made by Clem Waskow, seconded by Wilbert Sauermilch, which carried unanimously.

The Operating Permit Amendment Application is requesting an additional 17 AF of water per year for a total of 50 AF of water per year and a combined total of 380.89 AF of water per year from eight water wells. This property is located on FM 766 near Cuero, Texas and involves 1,867 acres. No public comment or objection stated.
- b. Discussion and consideration of operating permit application from BHP Billiton on Blake Muir's property: A motion to approve the Operating Permit Amendment Application in the amount of an additional 17 AF of water per year for a total of 50 AF of water per year and a combined total of 380.89 AF of water per year from eight water wells was made by Tim Pennell, seconded by Wilbert Sauermilch, which carried unanimously.

#### PUBLIC HEARINGS CLOSED AT 2:30 P.M.

30. Discussion regarding complaints about permitted well #0268 and water table dropping: Board heard comments from Roy Richter, Craig Wenske, Jamie Kelly and Dwane Kelly about having to lower their pumps due to water levels dropping. They believe that permitted well #0268 issued for commercial water sales is causing the water level to drop. Attorney Allison explained the District position and that any rule changes would have to apply to all landowners in the area if special emergency needs were identified and that course of action pursued. He suggested that the concerned landowners contact the holder of permit #0268 and discuss possible solutions to the problem since the well in question is pumping well below the allowable amount. GM was asked to make a site visit and gather further information for future consideration.

- 31. Minutes from 07-15-14 Meeting (provided prior to meeting): A motion to approve the minutes as presented was made by Clem Waskow, seconded by Marvin Sager, which carried unanimously.
- 32. Financial Reports July (provided prior to meeting): A motion to approve the July financial reports as presented was made by Wilbert Sauermilch, seconded by Marvin Sager, which carried unanimously.
- 33. Budget/Tax Rate Workshop: After discussion a motion was made to lower the current tax rate and set the District's FY 2015 tax rate at .0068% by Tim Pennell, seconded by Marvin Sager, which carried unanimously.
- 34. Discussion and consideration of moving the September board meeting date: A motion to move the date of the September board meeting to September 9, 2014, was made by Clem Waskow, seconded by Marvin Sager, which carried unanimously.
- 35. Discussion and possible action regarding enforcement actions against Carole Schultz and Brian Dlugosch, and an update regarding Kenneth Benbow: A motion was made to refer Carole Schultz and Brian Dlugosch to Attorney Allison for the third step in the Enforcement Policy was made by Wilbert Sauermilch, seconded by Marvin Sager, which carried unanimously. Attorney Allison reported that he had received a written request from Kenneth Benbow to cancel his permit and no further action is necessary in Mr. Benbow's case.
- 36. Discussion and consideration of office renovations: GM reported that Frank Burns has been ill and unable to prepare a lease for the District's current office space. No action will be taken until Mr. Burns prepares the lease document for consideration.
- 37. Discussion and consideration of Certification of Unopposed Candidates and Order Cancelling the Election for Precincts 1, 2, and 3: A motion was made to approve the Certification of Unopposed Candidates and the Order cancelling the election for Precincts 1, 2, and 3, by Wilbert Sauermilch, seconded by Marvin Sager, which carried unanimously.

#### 38. GM Report:

- a. Update on Water Quality Testing Program: GM reported that applications are continuing to be received. Board members would like to have a grid map of their precincts showing grids without applications.
- Update on Water Level Testing Program: GM reported that monitor well readings are currently being done and should be completed by next board meeting.

Closed Meeting (If necessary) – Executive session was called at 4:20 P.M. by Vice-Chairman Waskow to discuss matters regarding personnel pursuant to V.T.C.A. Government Code 551.074.

39. Closed Meeting (if necessary) – Executive session was called at 4:20 p.m. to consult with Attorney Allison.

- 40. Return to Open Meeting (If Necessary) Open Meeting was resumed at 4:40 p.m. GM was asked to do salary and insurance comparisons with the City of Cuero and DeWitt County.
- 41. Next Scheduled Board Meeting: Next meeting is scheduled for September 9, 2014.
- 42. <u>Adjournment</u>: The meeting adjourned at 4:45 P.M. with a motion by Tim Pennell, seconded Clem Waskow, which carried unanimously.
