

5. Public Hearing on Non-Exempt Operating Permit Application – Burlington Resources
 - a. Public Hearing on Non-Exempt Operating Permit Application submitted by Burlington Resources on Robert Schendel property for the beneficial use of Mining Oil and Gas. The application is requesting 650 acre-feet of water per year from this water well, which complies with District Rule 8.1.3 qualifying for additional production limits on deep water wells and elevated Total Dissolved Solids analysis. This property is located on Schendel Rd. near Yorktown and involves 798.03 acres.
 - b. Discussion and possible action on operating permit application from Burlington Resources.
